

Grundy Sample Bequest Language

**General Bequest** – NAMI Will-Grundy receives a specified dollar amount or percentage of your residuary estate.

*Example*: "I give, devise, and bequeath (a) the sum of \$\_\_\_\_\_\_ or (b) \_\_\_\_\_% of my residuary estate to NAMI of Will-Grundy County, Illinois, an Illinois nonprofit corporation located in Joliet, IL, (Federal Tax ID #90-0343172) to be used for its general use and purposes as the Board of Directors of NAMI Will-Grundy shall determine."

**Specific Bequest** – NAMI Will-Grundy receives a specified asset from your personal possessions such as stocks, real estate or works of art.

*Example:* "I give, devise, and bequeath \_\_\_\_\_\_ (description of a specific asset) to NAMI of Will-Grundy County, Illinois, an Illinois nonprofit corporation located in Joliet, IL, (Federal Tax ID #90-0343172) to be used for its general use and purposes as the Board of Directors of NAMI Will-Grundy shall determine."

**Residuary Bequest** – NAMI Will-Grundy receives all or a percentage of the remainder of your estate after any other gifts, debts, taxes and estate expenses have been paid.

*Example*: "I give, devise, and bequeath (a) all or (b) \_\_\_\_\_% of the rest, residue and remainder of my estate, both real and personal and wherever situated, owned by me at death, to NAMI of Will-Grundy County, Illinois, an Illinois nonprofit corporation located in Joliet, IL, (Federal Tax ID #90-0343172) to be used for its general use and purposes as the Board of Directors of NAMI Will-Grundy shall determine."

**Contingent Bequest** – NAMI Will-Grundy receives a bequest only if other beneficiaries predecease you or your estate exceeds a certain value.

*Example*: "If \_\_\_\_\_\_\_ (names of primary beneficiaries) should predecease me, then I hereby give, devise, and bequeath (a) all or (b) \_\_\_\_\_\_ % of the rest, residue and remainder of my estate, both real and personal and wherever situated, owned by me at death, to NAMI of Will-Grundy County, Illinois, an Illinois nonprofit corporation located in Joliet, IL, (Federal Tax ID #90-0343172) to be used for its general use and purposes as the Board of Directors of NAMI Will-Grundy shall determine."

To designate your bequest to a specific program: simply substitute "to be used to benefit NAMI Will-Grundy's (name of program)." to the language suggested above.
